



# TRACK RULES

1. Positively no dogs are permitted in the barn area.
2. Loose shavings and sawdust may NOT be stored in piles in barn area.
3. Horsemen using shavings and sawdust to bed stalls must use wagons or containers designated for removal of shavings and sawdust only.
4. Horsemen will be held financially accountable for repairs to race track property, particularly tack rooms, as a result of destruction or mutilation caused by them, their employees or other persons under their jurisdiction.
5. Security guards in barn area will have the authority to refuse entry of any motor vehicle and its occupants into the barn area at all times. Only authorized vehicles will be permitted in the barn area during training hours.
6. Only personnel licensed by the Illinois Racing Board are authorized to have free access to barn area at all times. Non-licensed persons may enter the barn area only as a guest of a licensed owner or trainer. Such persons will be required to sign a Daily Guest Register with the guard at the barn area main gate. Owners and Trainers will assume responsibility for the conduct and actions of their guests while in the barn area.
7. Admission passes and automobile parking stickers issued by management may not, under any circumstances, be loaned or transferred to another person or persons by the person to whom originally issued. Violations of this rule will result in permanent revocation of pass or passes and car sticker and possible criminal action against all parties concerned.
8. Cooking or smoking in barns, tack rooms or other enclosed areas located in the barn area is prohibited.
9. Names of departing and arriving horses must be recorded at the security gate. Evidence of all horses leaving or entering the track must be a matter of written record readily available at all times to the stewards and racing secretary.
10. Health certificates and current negative Coggins tests must accompany each horse before he is eligible to race at Fairmount Park or in the state of Illinois.
11. Allocation of stalls will be in accordance with Illinois Racing Board Rule.
12. By accepting stall space, all horsemen agree to recognize the Illinois Division of Horsemen's Benevolent and Protective Association as the exclusive representative of all horsemen racing at Fairmount Park Race Track.
13. Any trainer or owner stabling at Fairmount Park who directly or indirectly participates in the transport of a horse from Fairmount park to either a slaughterhouse, or an auction house engaged in selling horses for slaughter will be prohibited from having stalls at the track. The policy also applies to any actions related to the transport of a horse from Fairmount Park where the ultimate intended result is the horse's slaughter.

**NO OWNERS OTHER THAN THOSE ON THE STALL APPLICATION ARE ELIGIBLE TO RACE UNLESS APPROVED BY THE RACING SECRETARY AND MANAGEMENT.**

## **SPECIAL NOTICE**

**HORSES THAT ARE APPROVED ON THE STALL APPLICATION ARE THE HORSES THAT MUST ARRIVE AT FAIRMOUNT PARK ON AGREED DATE OR THOSE STALLS WILL REVERT TO MANAGEMENT IMMEDIATELY AND BE RE-ALLOTTED BY MANAGEMENT. ANY CHANGE OF HORSES (MUST BE OF COMPARABLE VALUE) HAS TO BE APPROVED BY THE RACING SECRETARY IN WRITING. HORSES THAT APPEAR ON MORE THAN ONE STALL APPLICATION WILL BE REFUSED STALLS ON EACH SUCH APPLICATION. HORSES ASSIGNED STALLS WILL NOT MOVE FROM ASSIGNED BARN WITHOUT PERMISSION OF THE RACING SECRETARY. ASSIGNED STALLS WILL BE SUBJECT TO REVIEW AND RE-ASSIGNMENT IF A TRAINER ACCEPTS STALLS AT ANOTHER RACE TRACK DURING THE THOROUGHBRED MEET AT FAIRMOUNT PARK.**

Having read all the conditions in this application, I hereby apply for stable accommodations for the horses listed hereon, and my acceptance and use of the stalls assigned to me shall be deemed my approval and agreement to abide by all the rules and regulations of the Illinois Racing Board, the Track Rules as stated here and any contract in effect between the track and the Illinois Division H.B.P.A.
