Event - 7:00 a.m. to 2:00 p.m. - Sunday, February 28, 2010.

Breakdown - 2:15 p.m. to 4:30 p.m. - Sunday, February 28, 2010.

5. Payment is due at time of application via the Fairmount Park website at www.fairmountpark.com. Full payment must be made by Monday February 22, 2010. No refunds will be issued for cancellations.
6. Displays must be professional looking with no hand written signs.
7. Booth assignment will be made by Fairmount Park management with preference given to early registrants.
8. Fairmount Park reserves the right to rule on all disputes who's judgment will be final.
