# TRACK RULES

1. Positively NO dogs are permitted in the barn area.
2. Loose shavings and sawdust may NOT be stored in piles in the barn area.
3. Horsemen using shavings and sawdust to bed stalls must use containers designated for removal of shavings and sawdust only.
4. Horsemen will be financially accountable for repairs to race track property, particularly tack room, as a result of destruction or mutilation caused by them, their employees or other persons under their control.
5. Security guards in the barn area will have the authority to refuse entry of any motor vehicle and its occupants into the barn area at all times. Only authorized vehicles will be permitted in the barn area during training hours.
6. Only personnel licensed by the Illinois Racing Board are authorized to have free access to the barn area at all times. Non-licensed persons may enter the barn area only as a guest of a licensed owner or trainer. Such persons will be required to sign a Daily Guest Register with the guard at the barn area main gate. Owners and Trainers will assume responsibility for the conduct and actions of their guests while in the barn area.
7. Cooking or smoking in the barns, tack rooms or other enclosed areas is prohibited.
8. Names of departing and arriving horses must be recorded at the security gate. Evidence of all horses leaving or entering the track must be a matter of written record readily available at all time to the Stewards and Racing Secretary.
9. All horses, including stable ponies, entering the Racetrack grounds must have a valid health certificate, issued within 5 days of transport, and list the required vaccinations which shall include:
  - (1) Verification of EEE/WEE/WNV (encephalitis), rabies and tetanus vaccinations within the prior 12 months.
  - (2) Verification of Influenza, Rhinopneumonitis and EHV-1 within the prior 180 days.
  - (3) Verification of a Negative Equine Infectious Anemia (Coggins) Test within 360 days.Health certificate, vaccination records and a current negative Coggins test must be on file in the Racing Office prior to entry into a race.
10. Allocation of stalls will be in accordance with the Illinois Racing Board rules.
11. By accepting stall space, all Horsemen agree to recognize the Illinois Division of the Horsemen's Benevolent and Protective Association as the exclusive representative of all Horsemen racing at Fairmount Park Race Track. \* (DBA Fanduel Sportsbook and Horse Racing.)
12. Any trainer or owner stabling at Fairmount Park \*who directly or indirectly participates in the transport of a horse from Fairmount Park\* to either a slaughterhouse, or an auction house engaged in selling horses for slaughter will be prohibited from having stalls and/or racing at the track. The policy also applies to any actions related to the transport of a horse from Fairmount Park \*where the ultimate intended result is the horse's slaughter. Any violation discovered will be reported to the Stewards and the Illinois Racing Board.

### **SPECIAL NOTICE**

HORSES THAT ARE APPROVED ON THE STALL APPLICATION ARE THE HORSES THAT MUST ARRIVE AT FAIRMOUNT PARK ON THE AGREED DATE OR THOSE STALLS WILL REVERT TO MANAGEMENT IMMEDIATELY AND BE REALLOTTED BY MANAGEMENT. ANY CHANGE OF HORSES (MUST BE OF COMPARABLE VALUE) HAS TO BE APPROVED BY THE RACING SECRETARY IN WRITING.

HORSES THAT APPEAR ON MORE THAN ONE STALL APPLICATION WILL BE REFUSED STALLS ON EACH SUCH APPLICATION.

HORSES ASSIGNED STALLS WILL NOT MOVE FROM ASSIGNED BARN WITHOUT PERMISSION OF THE RACING SECRETARY.

ASSIGNED STALLS WILL BE SUBJECT TO REVIEW AND REASSIGNMENT IF A TRAINER ACCEPTS STALLS AT ANOTHER RACE TRACK DURING THE THOROUGHBRED MEET AT FAIRMOUNT PARK. \* (DBA Fanduel Sportsbook and Horse Racing.)
